Per your request, the following letter is respectfully submitted in an attempt to discover why the General Partner did not receive the 2001 UBR before July 2001.

Chronologically, we established the Silos Partnership (Partnership) on November 30, 2000. We named following entity as the General Partner for the Partnership:
