dissolve on January1, 2040, unless sooner dissolved by law or by agreement of the parties hereto or unless extended by a majority agreement of the Partners.

- 8. Additional Contributions. No additional contributions of the Limited Partnership have been agreed upon.
- 9. Return of Contributions. No Limited Partner shall be entitled to withdraw or demand the return of any part of his or her capital contribution except upon dissolution of the Limited Partnership.
- 10. <u>Sale or Transfer of Interest in Partnership</u>. A Limited Partner shall not have the right to sell or transfer his or her interest in the Limited Partnership without the prior written consent of the partners, unless the transfer is a permitted transfer, as explained in detail by the Partnership Agreement.
- 11. <u>Additional Limited Partners</u>. The General Partner may admit additional limited partners.
- 12. <u>Continuance of Business</u>. Upon the death, retirement or insanity of the surviving General Partner, the Limited Partnership shall dissolve unless continued by the remaining Partners and selecting when necessary, by unanimous vote, a new successor General Partner.
- 13. <u>Property Other Than Cash</u>. A Limited Partner may not demand property other than cash in return for his or her contribution.
