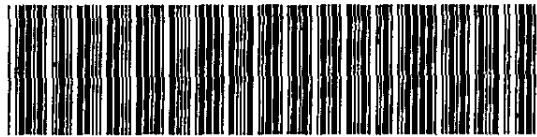

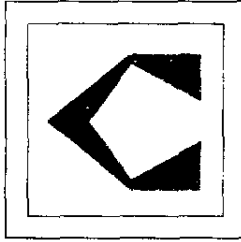

**SEVENTH AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF
