Ladies and Gentlemen:

The operating partners have requested that I respond to your request for Uniform Business Report (UBR) for 2003 (see copy enclosed).

Block 9 of the preprinted UBR form entitled "Capital Contributions as Shown on Record" indicates \$0; however, the company had originally filed an Affidavit of Capital Contributions to the NKST Family Limited Partnership (see copy enclosed) indicating total capital of \$2,500,000. Further, the law firm representing the partnership remitted \$1,810 to the Secretary of State (see front and back copy of check enclosed). The amount of capital contributions of record should be \$2,500,000. Since the original affidavit was filed and the tax was paid, a supplemental affidavit is not required. Accordingly, Block 9 of the UBR has been modified to indicate total capital of \$2,500,000.

Further, the company did not receive an original 2003 UBR. Had the form been received, the tax would have been paid and the form would have been timely filed. Accordingly, the company requests abatement of the \$400 penalty. A check in the amount of \$526.25 is enclosed with the executed UBR for your use in resolving this matter. If for any reason the abatement should not be approved, please contact the registered agent in writing at P.O. Box 1382, Bartow, FL 33831.
