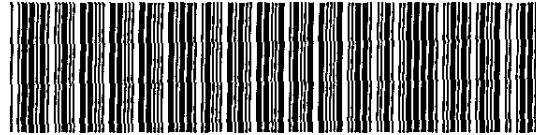

Enclosed with this letter you will please find our check number 6092 in the amount of \$52.50 payable to the Florida Department of State, together with duplicate originals of the Certificate of Cancellation of the Mary W. Martin Family Limited Partnership duly executed in our office on May 17, 2004. This has not been transmitted previous to this date for several reasons, which are discussed below.

You will also find enclosed the original Annual Report Notice sent to the Mary W. Martin Family Limited Partnership. The Partnership will not be filing an Annual Report, and respectfully requests that the Certificate of Cancellation be filed and made effective on or before December 31, 2004.

By way of background, the General Partner in March 2004, specifically on March 29, 2004, gave Notice of Intent to Dissolve the Partnership. The Certificate of Cancellation was signed on May 17, 2004, but not filed pending transfer of assets and pending issues dealing with Federal taxation.

On September 26, 2004, and September 27, 2004, the day of and the day after Hurricane Jeanne, one of four (4) hurricanes to strike Central Florida, three (3) of which had the eye pass through the City of Lakeland, Florida, we conferred with, and corresponded with the investment account holder, which still had title to the majority of the assets of this partnership. However, it was not before sometime in December, 2004, that the assets were actually transferred out of the partnership name.


Further, unfortunately, on December 18, 2004, the General Partner suffered a serious health reversal which delayed her ability to attend to the business of the Family Limited Partnership. We are presently assisting the General Partner in doing the final tax return for this partnership.

We therefore respectfully request that this document be filed and that the Cancellation of Partnership be made effective on or before December 31, 2004, failing which my client, the former General Partner of this partnership, has advised that she will simply allow it to be administratively dissolved since it has no assets and is doing no business during the year 2005.
