The Derry Housing and Redevelopment Authority was created at Town meetings under the Housing Authorities Law, RSA 203 and the Redevelopment Law, RSA 205, as a public corporate body. The powers of the Authority are vested in five commissioners appointed to five-year terms of office by the Town Council as provided for in Section 4.2(B) of the Derry Town Charter. The Authority shall provide housing for the low and moderate income people including the elderly, where practicable. It shall also look for opportunities to develop or re-develop properties, particularly in the downtown area. It should search for grants or low interest loans to accomplish its goals.

OPTIONAL

1. Housing - To prepare, carry out, acquire, lease and operate housing projects, to provide for the construction, reconstruction, improvement, alteration or repair of housing projects or any part thereof, and to contract with the owners or operators of any real property to make available to persons of low income at rentals within the financial reach of such persons, etc.
2. Redevelopment - To acquire blighted areas with buildings or improvements which ...are detrimental to the safety, health, morals or welfare of the community, and in general to undertake any activities necessary to carry out a redevelopment plan as approved by the governing body of the Town.

The operations of the Authority are conducted by an Executive Director and an Administrative Assistant.

**AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP
