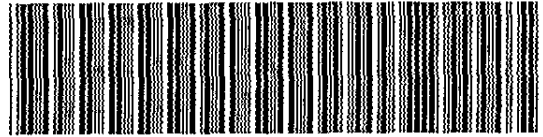

3. All debts, obligations and liabilities of the partnership have been either paid or adequate provision has been made for payment thereof.


4. All remaining property and assets of the partnership have or will be distributed to the partners.


5. There are no actions pending against the partnership in any court.
