Pursuant to the provisions of Section 620.109, Florida Statutes, the above named Florida limited partnership (hereafter the "Partnership"), whose certificate was filed with the Florida Department of State on May 23, 2001, adopts the following certificate of amendment to its Certificate of Limited Partnership.

FIRST: AmeraTAL, Inc., a Florida corporation, has been admitted to the Partnership as a new general partner.
