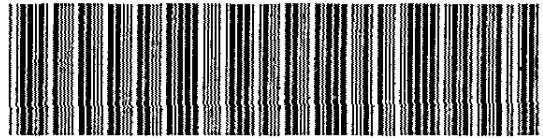



FIRST: Article I of the Certificate Of Limited Partnership is hereby amended to read as follows:


ARTICLE I. NAME
