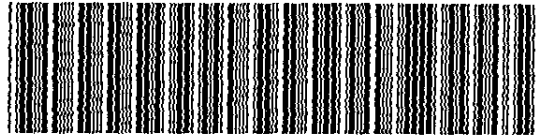

Paragraph 4 of the Certificate of Partnership is amended by substituting the following in lieu thereof:


