CERTIFICATE OF LIMITED PARTNERSHIP

OF

THE Y&A FAMILY LIMITED PARTNERSHIP

A Florida Limited Partnership

The undersigned General Partner desiring to form a limited partnership pursuant to the Florida Revised Uniform Partnership Act, as set forth in Part I, Chapter 620 of the Florida Statutes, adopts the following certificate for such limited partnership.

- 1. Name. The name of this Limited Partnership is THE Y&A FAMILY LIMITED PARTNERSHIP (the "Partnership").
- 2. <u>Business</u>. The general character of the Partnership business shall be to own, acquire, sell and lease investment real estate and other investment property of any type, kind or description, and to conduct a general business as thereto related.
- 3. <u>Principal Place of Business and Location of Records</u>. The location of the principal place of business of the Partnership is 2500 N.E. 32nd Court, Lighthouse Point, Broward County, Florida, at which place the records shall be maintained.
- 4. Registered Agent. The name and address of the registered agent for service for this Limited Partnership is: LARRY F. WITTE, ESQUIRE, at 201 S.E. 24th Avenue, Pompano Beach, Florida 33062, who acknowledges by his signature hereunder that he accepts same.
- 5. <u>The General Partners</u>. The names and business addresses of the General Partners are as follows: Yale L. Goldberg and Carol Ann Goldberg, both at 2500 N.E. 32nd Court, Lighthouse Point, Beach, Florida 33064.
- 6. <u>Mailing Address</u>. The mailing address of the Limited Partnership is 2500 N.E. 32nd Court, Lighthouse Point, Florida 33064.

- 7. Term. The Partnership shall begin at the time of the filing of the certificate of Limited Partnership with the Department of State and shall liquidate and dissolve on October 31, 2031, unless sooner dissolved by law or by agreement of the parties hereto or unless extended by a majority agreement of the Partners.
- 8. <u>Additional Contributions</u>. No additional contributions of the Limited Partners have been agreed upon.
- 9. Return of Contributions. No Limited Partner shall be entitled to withdraw of demand the return of any part of his or her capital contribution except upon dissolution of the Partnership.
- 10. Profits. - 11. <u>Sale or Transfer of Interest in Partnership</u>. A Limited Partner shall not have the right to sell or transfer his or her interest in the Partnership without the prior written consent of the partners, unless the transfer is a permitted transfer, as explained in detail by the Partnership Agreement.
- 12. <u>Additional Limited Partners</u>. The General Partner may admit additional limited partners.
- 13. <u>Priority Among Limited Partners</u>. There is no priority of one Limited Partner over another as to the contributions or compensation by way of income.
- 14. <u>Conveyance or Encumbrance of Real Property</u>. A conveyance or encumbrance of real property held in the partnership name, and any instrument affecting title to real property in which the Partnership has an interest shall be executed in the Partnership name by the General Partners.

- 15. <u>Property Other Than Cash</u>. A Limited Partner may not demand property other than cash in return for his or her contributions.
- 16. Affidavit of the Amount of Capital Contributions. The Limited Partners in the Limited Partnership will make capital contributions as set forth in Schedule "A", "Affidavit of the Amount of the Capital Contributions of the Limited Partners and Any amount Anticipated to be Contributed by the Limited Partners", attached hereto.
