As you can see in my letter of February 5, I raised this matter and pointed out that your documents needed to list both the names of the trusts, and the names of the trustees, if two trusts were indeed the general partners.

You can also see that when the documents were resubmitted to me, the general partners were identified as being two individuals.

So we filed this limited partnership listing the individuals -- Frederick D. Stevens and Patricia C. Stevens -- as general partners.

In the Supplemental Affidavit you are now presenting, you show the general partners as being trusts, and the two individuals as being trustees.

If the general partners are the individuals, then you need to correct the SUPPLEMENTAL AFFIDAVIT. If the general partners are trusts, then before you can file the SUPPLEMENTAL AFFIDAVIT, you'll need to file an AMENDMENT (fee \$52.50) listing the correct names and addresses of the general partners.
