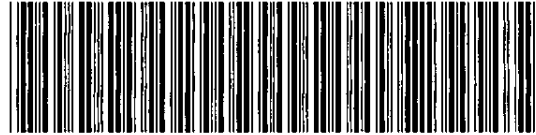


The undersigned, Cheryl Giffin, the sole general partner of PBS PARTNERS, LTD., hereby certifies that:
