SIXTH AMENDMENT TO THE LIMITED PARTNERSHIP AGREEMENT FOR STRATFORD MILL OF ST. JOHN'S CO. LTD.

The undersigned, desiring to amend the Limited Partnership Agreement of **Stratford Mill of St. John's Co. Ltd.**, a Florida limited partnership (the "Partnership") dated February 1, 2002, as amended April 1, 2002, and further amended April 11, 2003, May 18, 2004, December 15, 2004 and May 20, 2013, executes this Sixth Amendment to the Limited Partnership Agreement:

1. Lisa M. Stephens hereby withdraws as a limited partner of the Partnership. Notwithstanding anything to the contrary in this Limited Partnership Agreement, Paragraph 2.02 of the Limited Partnership Agreement is amended in its entirety as follows:

2.02 Limited Partner:

Stefan M. Davis and Davis Heritage, Ltd. shall be the Limited Partners of the Partnership. No other additional Limited Partners shall be admitted to the Partnership without the written consent of all the Partners. All persons, firms, and organizations who from time to time are Limited Partners in the Partnership, are sometimes hereinafter collectively referred to as "Limited Partners" and individually as "Limited Partner."

2. Notwithstanding anything to the contrary in this Limited Partnership Agreement, Paragraph 3.03 of the Limited Partnership Agreement is amended in its entirety as follows:

3.03 Units:

For purposes of allocating profits, losses, and cash flow, the Partnership shall be initially divided into one hundred (100) equal units, hereinafter referred to as the "units", which shall be distributed among the Partners as follows:
