To Whom It May Concern:

Please find enclosed a completed Limited Partnership Reinstatement request for the Reynolds Family Limited Partnership ("Partnership"). The Partnership was administratively dissolved on September 26, 2003 for failure to file its annual report.

The managers of the general partner (Reynolds, LLC) of the Partnership remained the same from the formation of the Partnership until June 20, 2007. The managers do not recall receiving notices for the prior years relating to the filing of the annual reports. The former managers traveled extensively and their mail may not have been forwarded correctly. The Partnership respectfully requests that the penalty fee of \$500.00 for each delinquent year be waived. The address for the Partnership has been changed to the undersigned's law office so that future annual Notices will be received and timely filed.

It is the undersigned's understanding that the Partnership has been administratively dissolved since the year 2003. Accordingly, I have enclosed a check made payable to the Department of State in the amount of \$3,000.00. This total includes annual report filing fees of \$411.25 per year for the years 2003, 2004, 2005, 2006, 2007 and 2008 (\$2,467.50 total) as well as supplemental fees of \$88.75 per year for the above-referenced six years (\$532.50 total).

Simultaneously with the submission of this letter to your office, the undersigned has submitted a limited liability company reinstatement request for the general partner of the Partnership, which general partner is Reynolds, LLC. Please delay the processing of this reinstatement request until the LLC reinstatement request is processed. It is the undersigned's understanding that the Partnership reinstatement request cannot be

processed unless the general partner is registered with the Division of Corporations and is current on its filing obligations. The undersigned has also included the registration document number for the LLC, which is the original document registration number for the LLC. If the LLC receives a new document registration number, the undersigned would appreciate your office substituting the new number for the number included in item 10. a. on the enclosed Partnership reinstatement request.
