I represent Footlight Investments, LLLP (the Partnership) and am writing in response to your letter to the Partnership dated June 3, 2003 (copy attached). There has been some confusion regarding the capital contributions and the fees for supplemental affidavits, but the confusion is readily resolved.

The Partnership received a supplemental capital contribution from its limited partners last year bringing the total capital contributions to \$4,465,628. The Partnership filed a supplemental affidavit on December 23, 2002 and paid an estimated fee of \$1,802.50. I attach a copy of the supplemental affidavit together with the certificate of filing.

No partner has made any capital contribution to the Partnership since the supplemental affidavit was filed December 23, 2002. Accordingly, no further supplemental affidavits are required and no additional fees are due.

When the Partnership filed its Uniform Business Report for 2003, it accidentally reported in box 10 the total capital contributions of all partners – general and limited. The Partnership also mistakenly paid \$750 as the annual fee instead of \$526.25.

The Department of State contacted the Partnership and, understandably believing that an additional 1% capital contribution had been made, instructed the Partnership to file a supplemental affidavit for \$45,565. \$45,565 is the difference between \$4,511,193 (as reported on the UBR) and \$4,465,628 (shown as total limited partner capital on 2002 supplemental affidavit).



The Partnership attempted to file a supplemental affidavit and submitted a check for \$95.21 (which, together with the prior payment of \$750, totaled the annual fee plus the supplemental affidavit fee on \$45,565). You returned the supplemental affidavit to the Partnership unfilled. Presumably believing that the entire \$4,411,193 reported in the erroneous supplemental affidavit was a new addition to capital, you understandably requested the full \$1750 fee.

I regret the confusion and inconvenience, and would appreciate your help in quickly resolving the matter. I understand that the Department of State has already accepted the 2003 UBR for the Partnership, but please let me know if the Partnership should file an amended UBR with the correct amount of limited partner capital contributions - \$4,465,628. The Partnership has paid a total of \$845.21, but only owed \$526.25. Please refund the balance of \$318.96.
