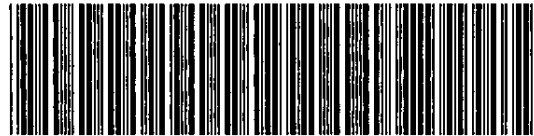



**CERTIFICATE OF AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP
OF INAW AT DELRAY, LTD., a Florida limited partnership**

THE UNDERSIGNED, as General Partner of INAW AT DELRAY, LTD., a Florida limited partnership, whose Certificate was filed with the Florida Department of State on July 16, 2002 and assigned Florida document number A02000000965, being the sole General Partner thereof, makes the following statement for the purpose of amending the Certificate of Limited Partnership previously filed with the Secretary of State, State of Florida, to-wit:

That pursuant to the Limited Partnership Agreement establishing INAW AT DELRAY, LTD., the Partners voted affirmatively to accept the following amendment to the Certificate of Limited Partnership:

1. That paragraph 6 of the Certificate of Limited Partnership of INAW at Delray, Ltd. is hereby deleted in its entirety and the following is substituted therefor:

"6. The latest date upon which the Partnership is to dissolve is January 1, 2033, unless otherwise continued in accordance with the terms of an amendment to this Certificate of Limited Partnership."

2. That the General Partner and the Limited Partners hereto acknowledge that, except as herein otherwise set forth, all of the terms, covenants and conditions of the Limited Partnership Agreement dated September 20, 2002, and any and all other documents relating thereto, shall remain in full force and effect as written.

3. That the Effective Date of this Certificate of Amendment is March 30, 2017.

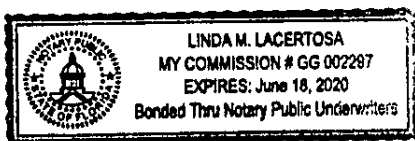
