1. The name of the Partnership is: WESTPOINT UNITED (CENTER), LTD.

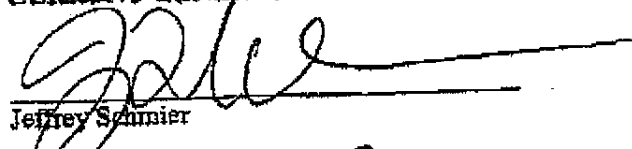

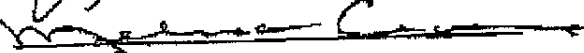
8. The name and address of the general partner of the Partnership is: WDC GP LLC, 7777 Glades Road, Suite 201, Boca Raton, Florida 33434.
