


AFFIDAVIT OF CAPITAL CONTRIBUTIONS



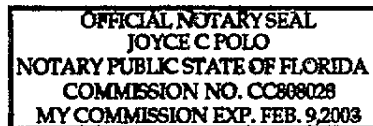
