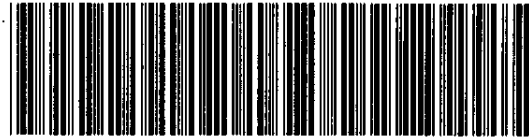

3. The reason for filing the Certificate of Dissolution is because one hundred percent of the Partnership's partners elected to dissolve the Partnership.


4. All of the assets of the Partnership have been distributed to the partners of the Partnership.




