**AMENDMENT TO THE CERTIFICATE OF AMENDED LIMITED
PARTNERSHIP OF SEABULK TANKERS, LTD.**

1. Section 5 of the Certificate of Amended Limited Partnership is hereby amended by deleting the text thereof in its entirety and inserting the following:

The term of the Partnership commenced on June 14, 1972, the effective date of the Limited Partnership Agreement, and shall end on June 14, 2025 unless sooner terminated under the provisions of the Limited Partnership Agreement, as amended.

2. This Amendment of the Certificate of Amended Limited Partnership shall be effective at the time of its filing with the Florida Department of State.

3. In all other ways, the Certificate of Amended Limited Partnership shall remain unchanged.
