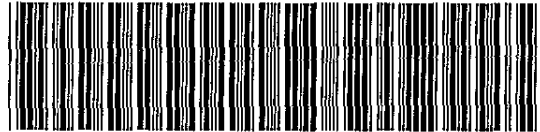

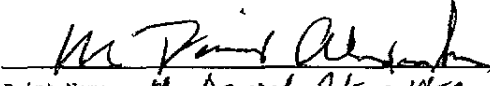

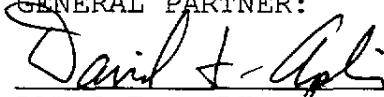

3. The total amount contributed and anticipated to be contributed by the limited partners at this time total is \$7,000,000.00.

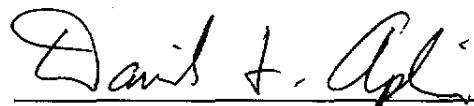

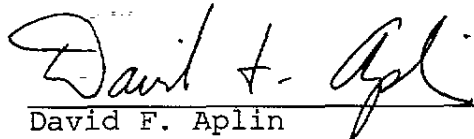
