Immediately following the admission of New River II GP, LLC, as a seneral partner of the Partnership, NRPII GP, LLLP, a Florida limited liability limited partnership having a mailing address of 115 NW 167th Street, #300, North Miami Beach, Florida #3165777 then a general partner of the Partnership, withdrew as a general partner of the Partnership.
