Section 6 of the Articles of Organization is hereby amended to read in its entirety as follows:

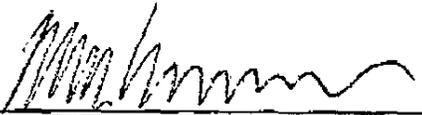
