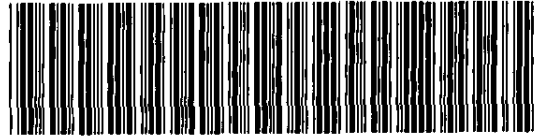

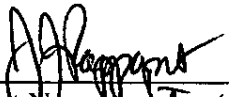
**ASSIGNMENT OF MEMBERSHIP INTEREST
