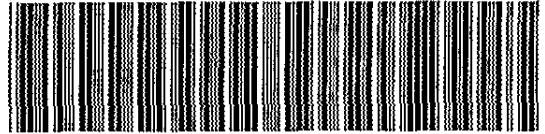

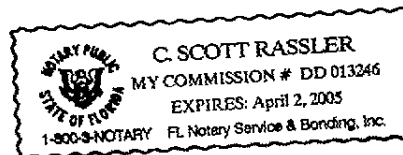

## Affidavit of Capital Contributions of Limited Partners



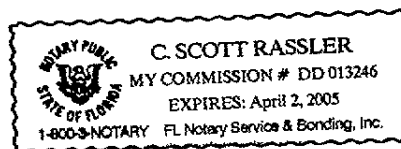
