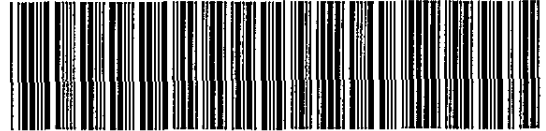

2. In all other respects the Certificate shall be unmodified.


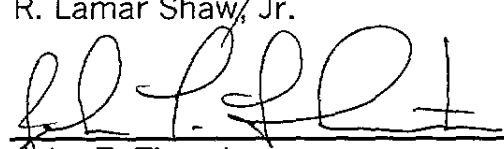
