

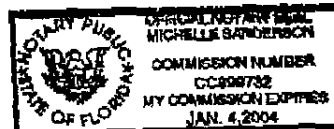


1. Affiant is an authorized representative of the **GREGG LICKSTEIN**, the General Partner, and is authorized to give this Affidavit.


