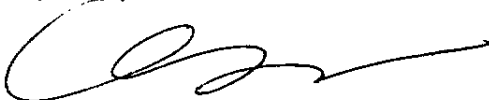

(3). The additional capital contributions anticipated at this time to be contributed by the Limited Partners is five million dollars (\$5,000,000.00).

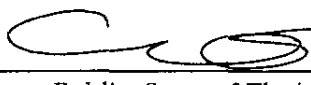
