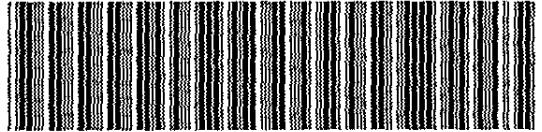

CHAPTER 620.109, AS AMENDED


