**CERTIFICATE OF DISSOLUTION OF
INDUSTRY PLAZA (LTD.),

Pursuant to the provisions of Sections 620.1203(1) and 620.1801(2) of the Florida Revised Uniform Limited Partnership Act of 2005, and effective as of 11:59 p.m. on December 31, 2006, the undersigned limited partnership adopts the following Certificate of Dissolution for the purpose of dissolving the limited partnership:
