SECOND AMENDMENT TO AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF COMPTON PROPERTIES, LIMITED

- 3. <u>Effect of Amendment.</u> Except as amended hereby and by the above-mentioned amendment filed in the Office of the Florida Secretary of State on August 26, 1985, the Amended and Restated Certificate of the Partnership remains in full force and effect.
