Compton Properties, LLLP whose original certificate was filed with the Florida Department of State on September 22, 1972, and assigned Florida document number A03145, adopts the following Amendment to its Certificate of Limited Partnership:

FIRST: DATE OF DISSOLUTION: The Partnership shall continue (a) until the Partnership has dissolved pursuant to the terms of the Limited Partnership Agreement for Compton Properties, LLLP, (b) until disposition of all or substantially all of the Partnership's assets, or (c) until December 31, 2020, whichever first occurs.
