## AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSTIP FLORIDA **OF** COMPTON PROPERTIES, LLLP

FIRST: DATE OF DISSOLUTION: The Partnership shall continue (a) until the Partnership has dissolved pursuant to the terms of the Limited Partnership Agreement for Compton Properties, LLLP, (b) until disposition of all or substantially all of the Partnership's assets, or (c) until December 31, 2020, whichever first occurs.
