AS OF THE DATE OF THIS ADDENDUM (AMENDMENT'S)
FILING WITH THE FLORIDA DEPARTMENT OF STATE
DIVISION OF CORPORATIONS:

(N) PARTNERSHIP BANK ACCOUNT: THE GENERAL PARTNERS
SHALL OPEN A PARTNERSHIP BANK ACCOUNT IN THE
NAME OF THE VJK FAMILY LIMITED PARTNERSHIP, AT
ANY FEDERALLY INSURED BANK OR SAVINGS AND LOAN
ASSOCIATION IN ANY STATE THE PARTNERSHIP IS DOING
BUSINESS. AS A LIMITED PARTNER VINCENT J. KROCKA
HEREBY POSSESSES AN IRREVOCABLE POWER OF ATTORNEY
WHICH SHALL BE EVIDENCED THROUGH APPROPRIATE
DOCUMENTS PROVIDED AND OR UTILIZED BY THE BANK
OR SAVINGS AND LOAN OF DEPOSIT, AND SHALL HAVE

THE SAME RIGHTS AND POWERS TO DEPOSIT AND WITHDRAW PARTNERSHIP FUNDS AND TO OTHERWISE HAVE THE POWER TO TRANSACT ANY AND ALL LAWFUL BUSINESS PURPOSES AS DEEMED NECESSARY IN HIS DISCRETION AS ANY GENERAL PARTNER, INCLUDING REMOVAL OF FUNDS TO AN OUT OF STATE BANK, SAVINGS AND LOAN, OR OFFSHORE BANK, WHOSE PRINCIPAL PLACE OF BUSINESS IS LOCATED IN A FOREIGN NATION. 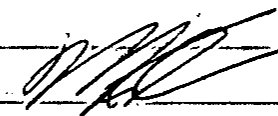
