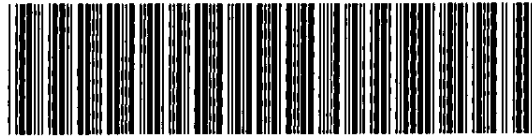

3. The date of filing of the initial Certificate of Limited Partnership for this Limited Partnership was February 17, 2004.

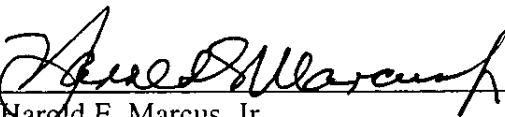
