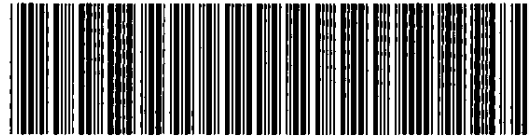

THIRD: The erroneous information or defect is as follows:


