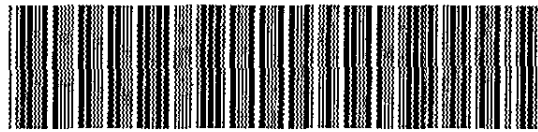

1. Name. The name of this Limited Partnership is THE MANUEL CASANOVA FAMILY LIMITED PARTNERSHIP.

2. Business. The general character of the Partnership business shall be to hold and manage investments, and conduct a general business as thereto related.

3. Principal Place of Business. The location of the principal place of business of the Partnership is 16471 S.W. 18th Street, Miramar, Broward, Florida.

4. Registered Agent and Office. The registered agent for this Limited Partnership is Iris Casanova. The street address of the registered agent and the registered office is 16471 S.W. 18th Street, Miramar, Florida 33027.

6. Term. The Partnership shall begin on the 29th day of June, 2004, and shall continue for 25 years thereafter unless sooner dissolved by law or by agreement of the parties hereto or unless extended by a majority agreement of the Partners.

8. Return of Contributions. No Limited Partner shall be entitled to withdraw or demand the return of any part of such Partner's capital contribution except upon dissolution of the Partnership.

13. Continuance of Business. Upon the death, retirement, or insanity of the surviving General Partner, the Partnership shall dissolve unless continued by the remaining Partners and selecting, when necessary, a new General Partner. If the last






