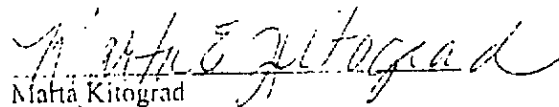
**CONSENT IN LIEU OF MEETING
