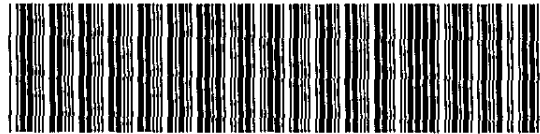

The total amount of the capital contributions of the limited partnership is \$15,000,000.


