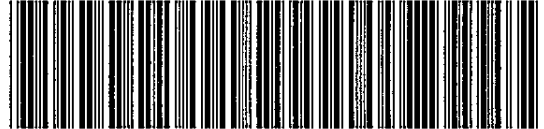





Clause 1: Name and Type of Partners

Anthony Andrews—General Partner

Clause 2: Duties and Responsibilities of Partners

The General Partner is solely responsible for the daily operations and management of the LLLP. The General Partner has all the rights: to defend the LLLP in any litigation or litigious matter—particularly by using the LLLP's funds/assets WITHOUT the consent of the limited partners, to buy or sell the LLLP's assets or property WITHOUT the consent of the limited partners, to purchase services and properties on behalf of the LLLP WITHOUT the consent of the limited partners, to dissolve the LLLP WITHOUT the consent of the limited partners, and to perform any other act by law.

The Limited Partners are solely responsible and liable for the distribution of the capital gains, profits, and losses in proportion to the amount originally and hereafter contributed to the LLLP by any of the partners.

Clause 3: Dissolution

The LLLP is only dissolved by the General Partner, without the consent of the limited partners, and is complete once the dissolution is filed with the Department of State.

Clause 4: Miscellaneous

Any clause or provision of the certificate of limited partnership can only be modified by the General Partner by filing the appropriate amendment with the Department of State.
