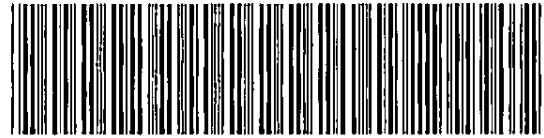

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "LLC Act"), the undersigned persons hereby deliver the following Articles of Merger:

1. The name, entity type and jurisdiction of formation of each of the constituent entities to the merger are as follows:

2. HD Supply Facilities Maintenance, Ltd., a Florida limited partnership, will be the surviving limited partnership (the "Surviving Partnership") in the merger.
3. The merger was approved by Presto Distribution, LLC in accordance with the provisions of Sections 605.1021-605.1026 of the LLC Act and by each member of Presto Distribution, LLC who, as a result of the merger, will have interest holder liability under Section 605.1023(1)(b) of the LLC Act and whose approval is required. The merger was approved by the partners of HD Supply Facilities Maintenance, Ltd. in accordance with the Florida Revised Uniform Limited Partnership Act of 2005.
4. At the effective time of the merger, the certificate of limited partnership of HD Supply Facilities Maintenance, Ltd. will continue as the certificate of limited partnership of the Surviving Partnership.
5. The Surviving Partnership has agreed to pay to any members of Presto Distribution, LLC with appraisal rights the amount to which such members are entitled under the provisions of Section 605.1006 and Sections 605.1061-605.1072 of the LLC Act.
6. These Articles of Merger and the merger contemplated hereby shall be effective at 12:01 a.m. Eastern Time on October 1, 2019.


