- 6. The Johnson Trust U/A/D August 19, 1971 was removed as General Partner as of April 5, 2005, and replaced with the General Partners identified in paragraph 5, above.
- 7. This Amended and Restated Certificate of Limited Partnership shall become effective upon its recording with the Florida Secretary of State.

Note: for purposes of clarification, Richard D. Fiske, as Trustee and Helen Sandra Fiske Anderson (a/k/a Helen S. F. Anderson and Helen Sandra Fiske), as Trustee, were the co-trustees of The Johnson Trust, as reflected on the Amended and Restated Certificate of Limited Partnership of Naples Dinner Theatre Associates, Ltd. dated June 14th, 1999 and filed with the Division of Corporations for the State of Florida, Subsequent annual reports through the year 2004 correctly identified Helen S.
