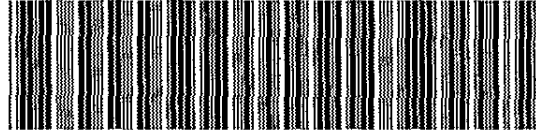

**SIXTH AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP
BROOKSVILLE HOMES, LTD.**

Pursuant to Section 620.1202, Florida Statutes, this Limited Partnership files this Amendment as set forth below:

BACKGROUND AND FACTS:

A. The name of the partnership is Brooksville Homes, Ltd. and the date of filing the original Certificate of Limited Partnership was August 14, 1975.

B. The amendments to the Limited Partnership Agreement Brooksville Homes, Ltd. dated May 2, 1975, are as follows:

1. Amended Limited Partnership Agreement Brooksville Homes, Ltd. dated November 12, 1975.

2. Amendment to Limited Partnership Agreement of Brooksville Homes, Ltd. dated January 2, 1976.

3. Second Amendment to Limited Partnership Agreement of Brooksville Homes, Ltd. dated October 10, 1980.

4. Third Amendment to Limited Partnership Agreement of Brooksville Homes, Ltd. dated October 11, 1981, and filed April 3, 1986.

5. Fourth Amendment to Limited Partnership Agreement of Brooksville Homes, Ltd. dated April 1, 1986, and filed May 28, 1986.

6. Fifth Amendment to Certificate of Limited Partnership of Brooksville Homes, Ltd. filed August 13, 1998.

C. The General Partner of Brooksville Homes, Ltd. is Barbara A. Magalski.

D. The limited partners of Brooksville Homes, Ltd. are John M. Curtis, Gail W. Curtis, Jon Oswald and Herbert C. Weiser.

Brooksville Homes, Ltd. adopts the following amendment to its Certificate of Limited Partnership as follows:

1. Section 1.04 of the Limited Partnership Agreement of Brooksville Homes, Ltd. dated May 2, 1975, and section 1.04 of the Amended Limited Partnership Agreement of Brooksville Homes, Ltd. dated November 12, 1975, both sections read as follows:

The Partnership shall commence as of the date of this Agreement and said partnership shall continue in force until December 31, 2025, unless sooner terminated in accordance with other provisions of this Agreement.

The above Sections 104 are hereby deleted in their entirety and the following shall replace and amend both sections:

1.04 Period of Existence:

The Partnership shall commence as of the date of this Agreement and said partnership shall continue in force until December 31, 2040, unless sooner terminated in accordance with other provisions of this Agreement.

2. In all other respects the Limited Partnership Agreement together with all amendments as referred to above shall remain in full force and effect. The below signature is of the current General Partner of Brooksville Homes, Ltd.
