POWER OF ATTORNEY

The undersigned makes, constitutes and appoints THOMAS M. GRAHAM, JR., JOHN A. WERWAISS, VINCENT S. ANDREWS and ROBERT A. FORLIZZO, and each of them, with full power of substitution, his true and lawful attorney, for him and in his name, place and stead and for his use and benefit to sign, swear to, acknowledge, file and record: (a) a certificate of limited partnership of the Colony East Associates, Ltd. (the "Partnership") as well as amendments thereto, under the laws of the State of Florida, or the laws of any other state or jurisdiction in which such certificate or any such amendment is required to be filed; (b) any other instrument which may be required to be filed or recorded by the Partnership under the laws of any state or by any governmental agency, or which the General Partner deems it advisable to file or record, and (c) any document which may be required to effect the continuation of the Partnership, the admission of a substituted Limited Partner to the Partnership, or the dissolution and termination of the Partnership, provided that such documents are in accordance with the terms of the Limited Partnership Agreement of the Partnership.

The foregoing grant of authority: (i) is a special power of attorney coupled with an interest, is irrevocable, and shall survive the death of the undersigned; (ii) may be exercised by any of the attorneys for each Limited Partner by

a facsimile signature of the attorneys or by listing all of the Limited Partners executing any instrument with a single signature of any of the above-named acting as attorney in fact for all of them, and (iii) shall survive the delivery of an assignment by a Limited Partner of the whole or any portion of his interest, except that where the assignee thereof has been approved by the General Partners for admission to the Limited Partnership as a substituted Limited Partner this power of attorney shall survive the delivery of such assignment for the sole purposes of enabling the attorneys to execute, swear to, acknowledge and file any instrument necessary to effect such substitution.

The total capital contribution of the limited partners will thus be \$100,000.

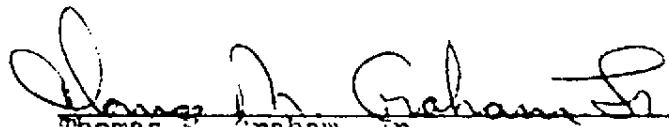
8. The contribution of each limited partner is to be returned to him upon the dissolution or other termination of the Partnership.
