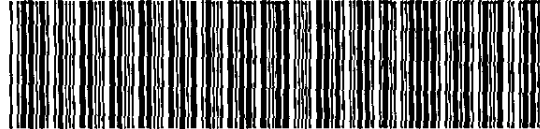

"1. The amount of capital contributions to the Partnership made by the Limited Partners is Nine Hundred Eighty and No/100 Dollars (\$980.00). "


