## PLAN OF MERGER OF LEGENDS BAY INVESTMENTS, LLC, WITH AND INTO SARABAY ASSOCIATES, L.L.L.P.

Sarabay Associates, L.L.L.P., a Florida limited liability limited partnership, and Legends Bay Investments, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 605.1022, Florida Statutes, and Section 620.8916, Florida Statutes. The terms of the plan are as follows:

- 1. The names of the business entitles planning to merge are Sarabay Associates, L.L.L.P., a Florida limited liability limited partnership ("Sarabay"), and Legends Bay Investments, LLC, a Florida manager-managed limited liability company ("Legends"). As a result of the merger, Legends shall be merged with and into Sarabay. Sarabay shall be the surviving business entity.
- 2. The merger shall be effective on the date the Articles of Merger are filed with the Department of State (the "Effective Date").
- 3. The name and address of the Manager of Legends is Roger L. Holland, 421 Bowdoin Circle, Sarasota, Florida 34236.
- 4. The name and address of the General Partner of Sarabay is HP-SA, LLC, a Florida limited liability company, P. O. Box 516, Hanover, Pennsylvania 17331.
- 5. This plan shall be submitted to the Member and Manager of Legends for approval. This plan shall be submitted to the General Partner and Limited Partner of Sarabay for approval.
- 6. The Limited Partner of Sarabay having a partnership interest in Sarabay prior to the Effective Date will hold the same partnership interest, with identical designations, preferences, limitations, and relative rights, immediately after the merger.
- 7. Legends and Sarabay are hereby authorized to amend this plan at any time prior to the filing of the Articles of Merger, to the extent permitted by law.
  - 8. There are no other terms of or conditions to the marger.
