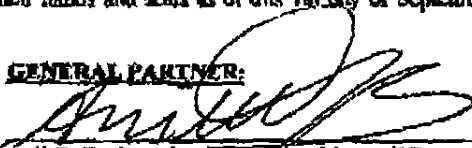
1. The current name of the Partnership is CASA INVESTMENT I, LP.

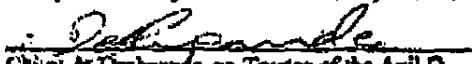
