#### AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF FOX HOLLOW ASSOCIATES, LTD.

    - (b) except as described in that certain Amended and Restated Agreement of Limited Partnership of Fox Hollow Associates, Ltd. dated as of March 1, 2006, not incur, assume or guaranty any indebtedness other than indebtedness expressly permitted by the Partnership Agreement or the documents evidencing or securing the Bonds;
    - (c) not violate or fail to comply with the covenants to maintain its identity as an entity separate from any other person or entity as set forth in Section 4.5 of the Partnership Agreement.
