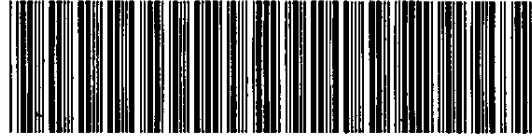




The limited partnership has completed winding up its affairs and wishes to file a statement of termination.
